Report of the Cultural Identity and Development Committee CIDC

Taking into Account the Changes and Demands

Since the last ITI World Congress the CIDC has gone through a dynamic process of finding a new structure for the committee. CIDC needs to evolve in order to take into account the demands of the world and the fast changes happening around us. To replace the General Secretary in a radical way by two young members failed.

Board Meeting in Manila 2012

The board meeting in Manila/Philippines, in February 2012, aimed at stabilizing the work of CIDC without putting any of the projects at risk. At the board meeting in Baku/Azerbaijan, in November 2012, it was decided to give the former General Secretary Alexander Stillmark from Germany and Anette Asp Christensen from Denmark the task of the General Secretariat of CIDC ad interim. Anette Asp Christensen should be introduced into the work of a general secretary of CIDC and be presented at the next congress. As the location for the next congress was changed, the decision proved to be appropriate because a lot of work on communication had to be done.

Joint Committee and ITI Executive Board Meeting in Paris 2013

During the 4th Joint Committee and Executive Board Meeting (November 2013, Paris) the members of CIDC presented the experience with the structure, together with the observation to the Executive Board and to the office bearers of other committees and listened to the critical remarks of the Executive Board members and the Director General of ITI.

Board Meeting in Lecce 2014

Transformation of CIDC into 3 Project Groups During the board meeting in Lecce/Italy in April 2014 the board members decided that the following solution should be communicated to the Executive Council of ITI. The CIDC is to be divided into smaller units:

- 1. Theatre in Conflict Zones. This Project Group includes projects like WALLS (Italy, Turkey, Cyprus, etc.), My Unknown Enemy (Germany), Centre for Theatre in Conflict Zones (Sudan).
- 2. Staging Cultural Identities. This Project Group deals with traditions like the Festival of Latin America and Caribbean (Colombia), Maya Project (Mexico), Ancient Greek Drama Festivals (Cyprus), and projects in Brazil and Australia, with Migrant Theatre like Ma-Yi Theatre in USA and with minorities like the work with Roma.
- **3. Theatre for Social Change** This committee deals with Community Work (Philippines, Mexico, etc.; with Theatre of the Oppressed (Brazil, etc.), and with Climate Change (Philippines, etc.).

According to the Rules and Guidelines Committees, Forums and Groups are independent to decide on their own structure.
